## **Presentation Descriptions**

#### **Ontario Traffic Manual Book 18: Cycling Facilities**

Dave McLaughlin, MMM Group Limited

Dave will highlight some of the new cycling facility design guidelines identified in OTM Book 18; Cycling Facilities (2013), and present some examples of recently implemented or planned projects that demonstrate application of the guidelines. His presentation will also include a few highlights from the Ministry of Transportation of Ontario's (MTO) new Bikeway Design Manual (2014), which is based on similar design guideline principles as OTM Book 18, but intended for provincial highway planners and engineers. Dave will conclude with some recommendations from OTM Book 18 regarding maintenance, risk management and liability as it relates to cycling infrastructure.

#### **Bicycle Facilities and Municipal Liability**

Belinda Bain, Gowling Lafleur Henderson LLP

Belinda will speak on the fundamentals of municipal liability in relation to active transportation infrastructure, including applicable statutory and common law duties. The presentation will touch on issues relating to the appropriate use of curb cuts on multi use/cycling trails, as well as potential liability of employers and/or schools encouraging increased cycling.

#### Police Perspective on Cycling and Enforcement

10:15 am - 10:45 am - Constable Hugh G. Smith, Toronto Police Service, Traffic Services

Hugh will tackle the interpretation of the law, such as the Highway Traffic Act, by police, when enforcing laws dealing with cycling and motorist interactions. In particular, the problems police agencies are having, when dealing with definitions and other laws that don't support one another. E.g. Municipal Bylaws vs. Highway Traffic Act vs. Criminal Code. He will also cover the more difficult questions of right of way for cyclists being passed by motor vehicles and new Toronto by-laws that address cycling on sidewalks, cycle-tracks, contra flow lanes and parks. His presentation will also include clarifying the cycling rules around E-bikes and new alternative electric vehicles as well as his own experience successfully working with a school to promote cycling to school.
